ISSUE: 2016 Iowa DOT Construction Projects in the Des Moines Metro & FY 2016-2019 Transportation Capital Improvements Plan

REPORT: Discussion regarding Iowa DOT's Construction Projects for 2016 and the FY 2016-2019 Transportation Capital Improvement Plan.

BACKGROUND:

The Iowa DOT District 1 will provide an update on construction projects in the Des Moines Metro planned for 2016.

The MPO staff will also discuss the FY 2016-2019 Transportation Capital Improvement Program.

The Fiscal Year 2016-2019 Transportation Capital Improvement Program (TCIP) lists upcoming capital improvement projects that affect the transportation system within the Des Moines Area Metropolitan Planning Organization's (MPO) boundary. This document contains all planned transportation capital improvements for fiscal years 2016-2019, as of August 2015 (Fiscal Year runs from July 1 to June 30).

The TCIP is prepared annually for upcoming fiscal years and allows the MPO and its members to have a more comprehensive view of short-range transportation projects, both federally and non-federally funded. These transportation projects are compiled from MPO member governments' respective capital improvement programs (CIP). Governments that do not prepare CIPs provided a list of anticipated projects to be constructed between FY 2016-2019.

ITS, or Intelligent Transportation System, Architecture is used in the metro to help program projects and aid in the budgeting process by creating a plan to oversee the implementation of ITS infrastructure in the area. Examples of ITS infrastructure includes traffic message boards, intersection signalization coordination and improvements, ramp metering, etc.
