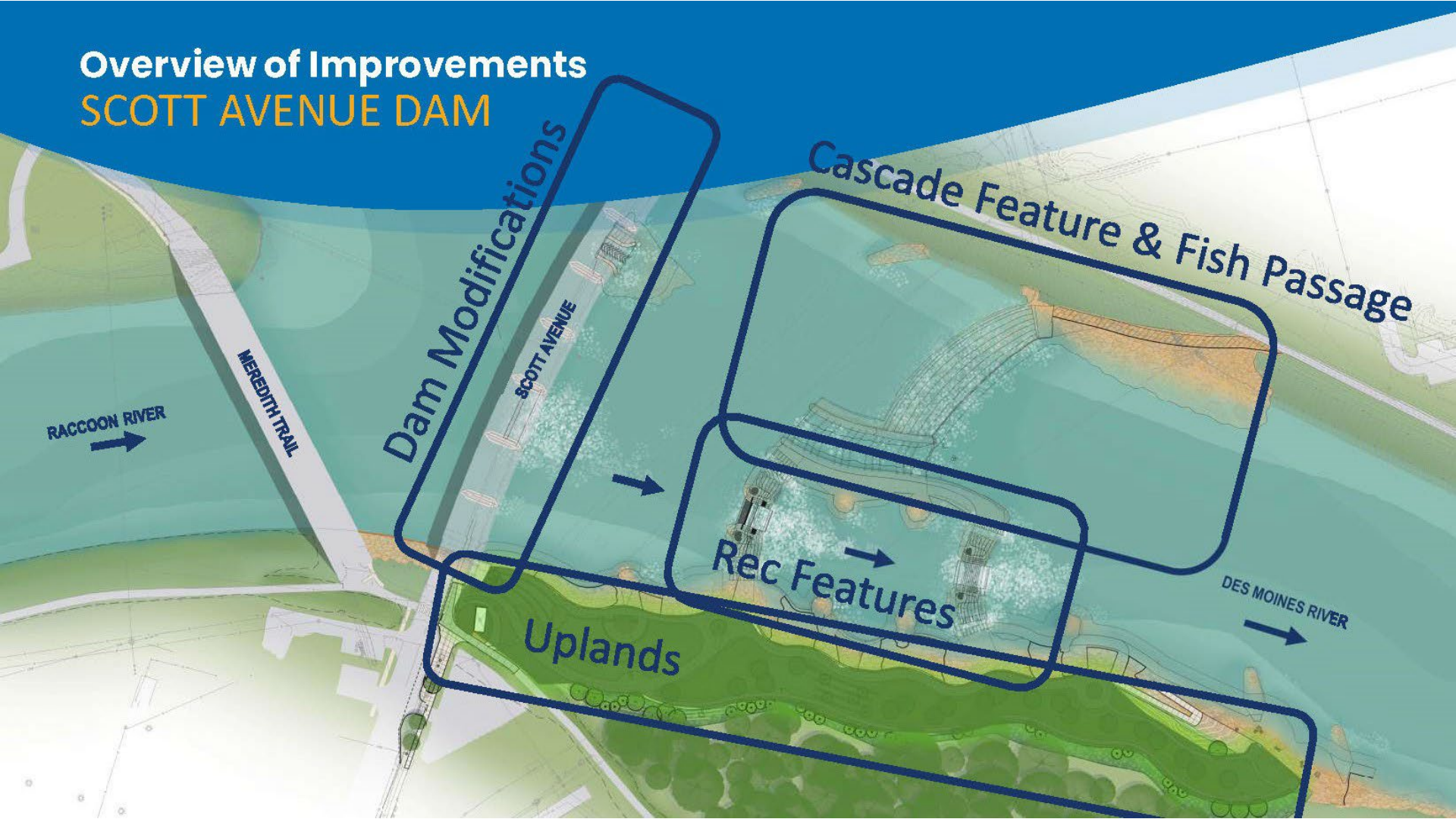
Contract for the Phase 1 Dam Mitigation and User Access Project

- Harriet Street Access – Bid Fall of 2023
- Scott Ave. Uplands– Bid Summer/Fall of 2024
- Prospect Park and Birdland Marina – Begin Construction by September 2027

Contract for the Phase 1 Dam Mitigation and User Access Project

- The MPO received one bid on the November 1st bid letting
- The bid received was from United/Reilly in the amount of \$40.9 million for the Scott Ave (in water) phase
- The BUILD Grant agreement budgeted \$40 million for the Scott Avenue (in water) phase of the project.

MOBILIZATION PAYMENT

Mobilization Payment



- The MPO needs to make an initial payment to contractor to keep the project off the FHWA's inactive list
- Staff proposes making a payment equal to 10 percent of the total mobilization costs
- This will amount to approximately \$386,043.
