
FFY 2024-2027 TRANSPORTATION IMPROVEMENT PROGRAM AMENDMENT

- Change: Increase total project cost to \$111,442,454







Scott Avenue Dam Change Order #1

- Next Steps
 - MPO approves draft in March and submits to Iowa DOT/FHWA/FTA
 - Iowa DOT/FHWA/FTA provide comments by end of April
 - MPO approves final in May and submits to Iowa DOT/FHWA/FTA
 - MPO-Iowa DOT planning agreement completed in June
 - New budget takes effect July 1
- Note: still time to make adjustments to document/budget before May MPO approval.



STREETLIGHT DATA



StreetLight Data

- In December, the committee heard presentations from two vendors of transportation analytics data.
 - ClearGuide and StreetLight
- Staff subsequently surveyed committee representatives.
 - Preference for StreetLight
- StreetLight offers numerous data modules for various use cases.
- Proposed subscription: \$80,000 annually
 - Vehicles and Freight modules
 - Regional subscription w/access for MPO members
- In draft FY 2025; recommend starting now to use on current projects





MOBILIZING TOMORROW: EMPLOYMENT, HOUSING UNIT, AND POPULATION PROJECTIONS

- What are the projections used for:
 - MPO uses Employment and Housing Unit projections to develop the growth scenario that feeds into the Travel Demand Model (TDM)
 - Population is not one of the model inputs
 - The MPO is required to update the TDM as part of the development of the LRTP
 - LRTP updated every 5 years



- What is the TDM/growth scenario is used for:
 - Tool to assist with regional transportation planning decisions
 - Helps set a baseline for studies and IJRs to be used along with other land use/growth scenarios
- What is the TDM/Growth Scenario is NOT used for:
 - Allocation of STBG or other federal funding programs
 - Determine what projects are built by communities
 - Determine how much a community actually grows in the future



Growth Scenario Development

- Used same methodology as the last plan update with updated census data
- Staff presented draft employment, housing unit, and population projections at the February Technical Committee meeting
- Presented item as optional vote and the Committee determined that they wanted some additional time to review
- Staff requested comments back by the end of February



- Staff received comments from the following communities:
 - Bondurant, Norwalk, Pleasant Hill, and Waukee
- Concerns shared were similar in nature focusing on population projections being low compared to the community's comprehensive plans
- Reason for differences:
 - MPO uses a control total
 - Different methodologies between comp plans and LRTP



Control Total

- Staff also reached out to the Iowa DOT and FHWA regarding the use of regional control totals
- The Iowa DOT recommend that the MPO continue to use an outside source to develop a control total



- Staff uses Woods and Poole for the independent source same source used by State Data Center
- Woods and Poole has the 4-county region projected population at 855,600 by 2050 (Dallas, Polk, Madison, Warren)
- The MPO projections shared last month have the projected population for just the MPO members at 850,150



- The challenge MPO staff are facing is that to address the comments received, we would have to move away from using a regional control total
- This would go against the recommendation of the lowa DOT



Option 1: Regional Control Total – Existing Methodology

- Pros
 - All member communities experiences positive growth
 - Maintains use of control total recommended by DOT
- Cons
 - Shows slower growth than some member comp. plans
 - Some communities have lower growth than expected (especially in out years)



Option 2: Regional Control Total (High Growth/Low Growth)

- Pros
 - Maintains use of control total recommended by DOT
 - Projections could match growth of some member comp. plans
- Cons
 - Projections would not match growth of some member comp. plans
 - Difficult process to determine which members do match and which do not



Option 3: Eliminate Control Total

- Pros
 - Address comments and concerns without having to select high growth/low growth communities
 - Could align more closely with comp. plan projections
- Cons
 - Could require development of a new methodology
 - Not all communities have recent comp. plan projections and/or inconsistency in comp. plan horizon years and methodology
 - Goes against the Iowa DOT's recommendation for using a control total
 - Could create issues during Iowa DOT/FHWA review of LRTP



- Option 2 seems like a non-starter
- That leaves the committee with a decision between staying with the Iowa DOT recommended control total or choosing to move away from a control total
- Staff has kept the recommendation the same as in February
 - Good practice to have a control total
- However, staff remains open to other options at the committee's direction.





FFY 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM DEVELOPMENT

FFY 2024-2027 TIP Development

- MPO develops a four-year Transportation Improvement Program (TIP) annually
- MPO member governments and associated agencies receive current TIP projects for review and update
- Federally funded FFY 2024 programmed projects must have FHWA authorization to proceed by September 30, 2024
- If not, a rollover to FFY 2025 is required
- Staff will be sending out the TIP status reports in late March/early April
